MI RU SU - 12/5/88 Killed well with fresh water. Released packer and pulled tubing and packer.

Set 5½" CIBP at 2145'. Pressure tested casing to 750#. Displace hole with gelled brine water, spotted 25 sx Class C neat cement from 2145'-1905'. Pulled tubing, tubing landed at 839', spot 25 sx Class C cement across casing shoe from 839'-600'. Tubing landed at 98', circulate cement to surface.

Rig down moved off service unit 12/6/88. Cut off wellhead and installed PxA marker. Cleaned up location.
