Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and
resumed drilling. Drilled to a TD of 2606' and ran 5-1/2" casing set at 2606'.
Cemented with 2000 SX Class H cement. Plugged down 4:30 a.m. 5-3-81.
Circulated 0 SX. Currently waiting on completion unit.
