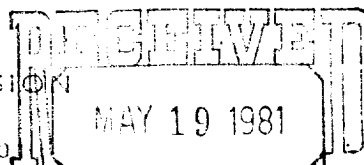

On 4-25-81 James Drilling (Rig #7) spudded a 12-1/4" hole at 9:30 a.m. Drilled to a TD of 715' and ran 8-5/8" casing set at 715'. Cemented with 500 SX Class H cement. Plugged down 4:00 p.m. 4-26-81. Circulated 150 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2560' and ran 5-1/2" casing set at 2560'. Cemented with 960 SX Class H cement. Plugged down 8:45 p.m. 5-1-81. Circulated 330 SX. Currently waiting on completion unit.
