Move in service unit 11-19-82. Pulled tubing, seating nipple, packer and tailpipe. Ran 5- joints fiberglass 2-3/8" tailpipe, 2-3/8" to 2-7/8" swage, 2-7/8" X5-1/2" plastic-coated packer, 2-7/8" plasticated seating nipple, and 2-7/8" plastic coated tubing. Hydro tested packer, seating nipple, and tubing into hole above slips to 5000 psi. Pumped 30 bbl inhibitor and set the packer at 2022', landing tailpipe at 2176'. Loaded annulus with 25 bbl inhibitor. Pressure tested packer to 500 psi and OK. Ran swab with initial fluid level 1200 ft. from surface. Swabbed 1 run and well kicked off. Recovered 40 BLW. Moved out service unit 11-22-82. Well shut-in. (Verbal approval by Carl Ulvog 10-4-82).
