MISU 7-9-85 and killed well with 20BW 27% KCL. Released packer and P.D.H. with production equipment. Ran casing gun on wireline and tagged P.B.T.D. at 2492'. Perforated 2025'-120' with 25PF. Re-ran production equipment. Tubing landed at 1854' and packer set at 1824'. Pressure tested casing 1000 psi - ok. Swabbed and flowed back 30 BBL. Stimulated with 20 tons CO₂ and 340 ball sealers. MISU 7-11-85 and returned well to production. Operations completed 8-13-85.
