On 3-31-81 Moran Brothers (Rig #56) spudded a 12-1/4" hole at 8:30 p.m. Drilled to a TD of 716' and ran 8-5/8" casing set at 716'. Cemented with 500 SX Class H cement. Plugged down 8:45 p.m. 4-1-81. Circulated 150 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 3463' and ran 5-1/2" casing set at 3463'. Cemented with 1000 SX Class H cement. Plugged down 7:45 a.m. 4-8-81. Circulated 315 SX. Currently waiting on completion unit.
