On 3-28-81 Aztec Drilling (Rig #56) spudded a 12-1/4" hole at 12:01 a.m. Drilled to a TD of 720' and ran 8-5/8" casing set at 708'. Cemented with 500 SX Class H cement. Plugged down 6:00 p.m. 3-30-81. Circulated 200 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2492' and ran 5-1/2" casing set at 2492'. Cemented with 750 SX Class H cement. Plugged down 12:55 p.m. 4-3-81. Circulated 210 SX. Currently waiting on completion unit.
