Moved in service unit 1-18-82. Pulled tubing and seating nipple. Perforated 2716'-23', 27'-31', and 33'-37' with 2 JSPF. Ran packer, tubing, and seating nipple. Set packer at 2691'. Acidized with 12 bbl 7-1/2% HCL with additives and radioactive material. Pulled packer. Moved out service unit 1-20-82. On 1-21-82 turned well thru a separator and flow tested for 171 hrs. Well flowed 8167 MCF and 22 BLW with an average of 1146 MCFD. Well shut-in 1-28-82.
