On 4-11-81 Aztec Drilling (Rig #50) spudded a 12-1/4" hole at 1:00 a.m. Drilled to a TD of 723' and ran 8-5/8" casing set at 723'. Cemented with 500 SX Class H cement. Plugged down 6:15 a.m. 4-12-81. Circulated 200 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 3880' and ran 5-1/2" casing set at 3880'. Cemented with 1150 SX Class H cement. Plugged down 4:15 p.m. 4-19-81. Circulated 200 SX. Currently waiting on completion unit.
