On 4-17-81 James Drilling (Rig #7) spudded a 12-1/4" hole at 10:00 a.m. Drilled to a TD of 711' and ran 8-5/8" casing set at 711'. Cemented with 500 SX Class H cement. Plugged down 2:30 p.m. 4-18-81. Circulated 158 SX. WOC 19 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2910' and ran 5-1/2" casing set at 2903'. Cemented with 1000 SX Class H cement. Plugged down 8:30 a.m. 4-24-81. Circulated 505 SX. Currently waiting on completion unit.
