Perforated casing at 2618'-26', 2629'-32', 2634'-43', 2653'-64', 2674'-76', 2722'-30', 2743'-52', 2753'-61', 2764'-67', 2776'-78', 2786'-88', 2974'-2806', 2810'-16', 2824'-26' with 1 JSPPF. Acidized with 4500 gal. 7-1/2% HCL acid. Swab tested. Ran cement retainer and set at 2506'. Squeezed cemented with 185 SX Class H cement. Drilled cement and retainer to 2666'. Tested squeeze to 1000 psi for 15 min. Held OK. Reperforated intervals 2618'-26', 2629'-32', and 2634'-43' with 2 DPJSPPF. Acidized with 1500 gal. 7-1/2% HCL. Fraced with 20000 gal. west foam and 20000# 10/20 sand. Flow tested thru a separator for 88 hrs. with an average of 199 MCFD. Well shut-in 6-6-81.
