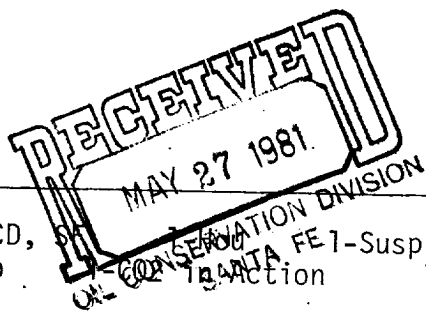

On 5-13-81 Aztec Drilling (Rig #50) spudded a 12-1/4" hole at 3:00 p.m. Drilled to a TD of 723' and ran 8-5/8" casing set at 723'. Cemented with 500 SX Class H cement. Plugged down 6:30 a.m. 5-14-81. Circulated 228 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2900' and ran 5-1/2" casing set at 2873'. Cemented with 850 SX Class H cement. Plugged down 7:30 p.m. 5-18-81. Circulated 258 SX. Currently waiting on completion unit.
