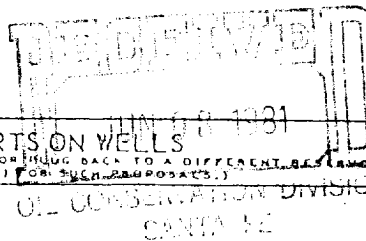

On 5-25-81 Salizar Bros. Drilling (Rig #13) spudded a 12-1/4" hole at 10:00 p.m. Drilled to a TD of 710' and ran 8-5/8" casing set at 701'. Cemented with 500 SX Class H cement. Plugged down 7:20 p.m. 5-26-81. Circulated 50 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2515' and ran 5-1/2" casing set at 2515'. Cemented with 800 SX Class H cement. Plugged down 4:15 p.m. 5-31-81. Circulated 252 SX. Currently waiting on completion unit.
