On 6-1-81 Salizar Drilling (Rig #13) spudded a 12-1/4" hole at 4:00 p.m. Drilled to a TD of 720' and ran 8-5/8" casing set at 716'. Cemented with 500 SX Class H cement. Plugged down 3:00 p.m. 6-2-81. Circulated 50 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2460' and ran 5-1/2" casing set at 2451'. Cemented with 750 SX Class H cement. Plugged down 12:00 p.m. 6-6-81. Circulated 220 SX. Currently waiting on completion unit.
