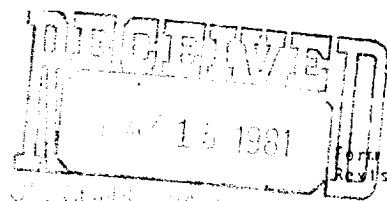

On 5-5-81 Skidded Cal Western Rig #5 100' east and spudded a 12-1/4" hole at 8:00 p.m. Drilled to a TD of 700' and ran 8-5/8" casing set at 700'. Cemented with 500 SX Class H cement. Plugged down 8:30 a.m. 5-7-81. Circulated 194 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2522' and ran 5-1/2" casing set at 2522'. Cemented with 900 SX Class H cement. Plugged down 5:30 p.m. 5-12-81. Circulated 227 SX. Currently waiting on completion unit.
