On 7-8-81 Aztec Drilling (Rig #50) spudded a 12-1/4" hole at 7:00 p.m. Drilled to a TD of 700' and ran 8-5/8" casing set at 700'. Cemented with 500 SX Class H cement. Plugged down 5:00 p.m. 7-9-81. Circulated 199 SX. WOC 19 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2949' and ran 5-1/2" casing set at 2949'. Cemented with 840 SX Class H cement. Plugged down 3:30 p.m. 7-16-81. Circulated 270 SX. Currently waiting on completion unit.
