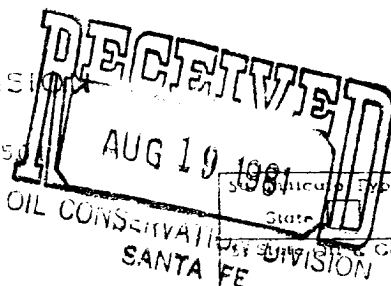

On 7-30-81 Aztec Drilling (Rig #50) spudded a 12-1/4" hole at 11:00 p.m. Drilled to a TD of 725' and ran 8-5/8" casing set at 725'. Cemented with 500 SX Class H cement. Plugged down 11:00 a.m. 8-1-81. Circulated 238 SX. WOC 20 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 3718 and ran 5-1/2" casing set at 3718'. Cemented with 1000 SX Class H cement. Plugged down 10:30 a.m. 8-10-81. Circulated 200 SX. Currently waiting on completion unit.
