Propose to plug and abandon as follows:

Run 2-3/8" tubing and circ. well with heavy mud. Spot 25 sacks class H cement on top of cast iron bridge plug set at 2401'. Spot 25 sacks class H cement across top of San Andres (approx. 1710'-1900'.) Spot 25 sacks class H cement across 8-5/8" casing shoe. Spot 10 sacks class H cement plug at surface. Weld on cap. Erect abandonment marker. Fill pits, level location and clear area of junk.
