Attached is a copy of the most recent report received by this agency. You may recall that on June 21, 1982, a request was made (by telephone) for information regarding the subject well, since inspection revealed operations had been suspended. You may also recall that during the telephone conversation, you indicated plans for plugging and abandoning the location.

On June 25, 1982 - along with the report here attached, was a copy of the borehole survey run on your well June 18, 1982. Based on fluid zones indicated by this log, and your description of lost circulation problems, a proposed plugging program was developed and relayed to you on June 25th (via telephone).

As of this date, no report of plugging has been received, although site inspection indicates the location has been abandoned. However, the mud pit is open and a regulation well marker has not been installed. Kindly note the attached copy of Rules 201, 202, and 1103.

Your cooperation in completing this project will be appreciated.
