All depths reported shall be measured in feet. In the case of directionally drilled wells, true vertical depths shall also be reported. For multiple completions, Items 1 through 34 shall be reported for each zone. The form is to be filed in triplicate except on state land, where six copies are required. See Rule 1105.
