Circulate 110 sacks cement. Test casing at 600 psi for 30 min. and OK. Logged. Ran 7" casing and set at 2553'. Cement with 600 sacks class H. Circulate 162 sacks. Plugged down at 11:08 am. on 8-28-83. Rig released at 1:30 pm on 8-28-83. Currently waiting on completion unit.
