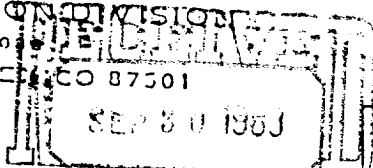

On 8-2-83 C02-In-Action (Rig #16) spudded a 12-1/4" hole at 11:30 pm. Drilled to 711' and set 9-5/8" casing. Cemented with 375 sacks class H and additives. Circulated 120 sacks and plugged down at 6:57 pm on 8-29-83. Tested casing for 30 min. at 600 psi and OK. Logged and ran 7" casing and set at 2576'. Cemented with 750 sacks class H and additives. Plugged down at 12:45 pm. Circulated 250 sacks cement to pit. Rig released at 2:30 pm on 9-2-83. Currently waiting on completion unit.
