On 9-2-83 CO2-In-Action (Rig #16) spudded a 12-1/4" hole at 9:30 pm. Drilled to 724' and set 9-5/8" casing. Cemented with 375 sacks class H and 2% CACL. Circulated 157 sacks cement to pit. Plugged down at 2:00 pm on 9-3-83. Tested casing at 600 psi for 30 min and OK. Sweep hole with 60 bbl mud and 10#/bbl LCM. Logged and ran 7" casing and set at 2590'. Cemented with 900 sacks class H and additives. Plugged down at 7:45 am on 9-7-83. Circulated 320 sacks cement to pit. Rig released at 9:15 am. on 9-7-83. Currently waiting on completion unit.
