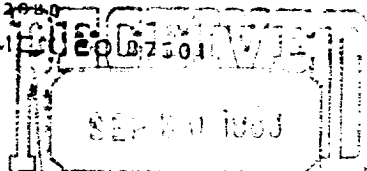

On 9-7-83 CO2-In-Action (Rig #16) spudded a 12-1/4" hole at 6:00 pm. Drilled to 700' and set 9-5/8" casing. Cemented with 375 sacks class H and additives. Plugged down at 10:30 am on 9-8-83. Circulated 114 sacks to Reserve. Tested casing for 30 min. at 600 psi and OK. Logged and ran 7" casing and set at 2679'. Cemented with 700 sacks class H and additives. Plugged down at 3:30 pm on 9-12-83. Circulated 155 sacks cement. Rig released at 5:30 pm on 9-12-83. Currently waiting on completion unit.
