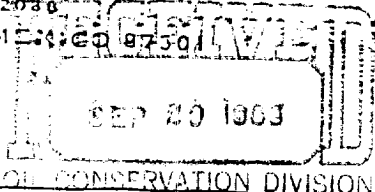

On 9-9-83 Aztec (Rig #171) spudded a 12-1/4" hole at 10:30 pm. Drilled to 733' and set 9-5/8" casing. Cemented with 375 sacks class H and additives. Plugged down at 1:00 pm on 9-10-83. Circulated 142 sacks to pit. Tested casing to 600 psi and OK. Fished and recovered 187' drill pipe. Logged and ran 7" casing set at 2672'. Cemented with 800 sacks class H and additives. Did not plug down. Shut down at 11:00 am 9-22-83. Circulated 386 sacks cement and float held. Rig released at 1:00 pm on 9-22-83. Currently waiting on completion unit.
