Circulated 95 sacks cement to reserve pit. Tested casing at 600 psi and OK. Fished stuck tool and recovered. Logged and ran 7" casing and set at 2606'. Cemented with 700 sacks class H and additives. Circulated 193 sacks cement to pit. Plugged down at 1:45 am on 9-5-83. Rig released on 9-5-83 at 4:30 am. Currently waiting on completion unit.
