Initiated W.D. 5-29-85. RU lubricator and ran sinker bar w/ WL and tagged PBTD at 2490'. Pulled up WL and sinker bar and loaded csg w/ 4 1/2 bbl pkr fluid. Pres. tested pkr and csg to 1000 psi - OK. Killed well and installed treating valve. Stimulated w/ 30 tons CO2 and 655 ball sealers. Bled well down for 1 hr. Killed well, removed treating valve and installed production equip. Turned well over to mock well testing.
