Propose to kill well with 2% KCLW and install treating valve. Stim and flow well for 1 hr to pit. Kill and remove treating valve. Swab and return to production. If production is not over 2 MMCFGPD proceed in running noise log. With the well flowing run a temp survey and noise log from TD to 1950'. Shut-in well and run a temp survey 30 min, 60 min and 90 min with the well shut in. Swab and return well to production.
