Tested casing at 600 psi for 30 min. and ok. Logged and ran 7" casing and set at 2584'. Cemented with 800 sacks Class H cement and additives. Circulated 359 sacks and plugged down at 3:32 p.m. on 10-7-83. Tested casing at 1500 psi for 30 min. and ok. Rig released at 6:00 p.m. on 10-7-83. Currently waiting on completion unit.
