On October 19, 1984 CO2 in Action Rig #16 spudded a 12 1/4" hole. Drilling to a total depth of 726' and set 9 5/8" casing. Cemented with 390 sacks class H cement with additives. Plugged down at 9:00 AM on 10-20-84. Circulated 95 sacks to reserve pit. Wait on cement for 12 hours. Tagged cement at 645' & tested casing with 600 PSI and ok. On October 26, 1984 ran and set 7" casing at 2856'. Cemented with 1150 sacks class H cement with additives. Plugged down at 4:45 PM on 10-25-84. Circulated 392 sacks cement to reserve pit. Rig released 7:45 PM on 10-25-84.
