On 11-8-83 Aztec Drilling Co. (Rig #56) spudded a 12-1/4" hole at 10:00 am. Drilled to 705' and set 9-5/8" casing. Cemented with 390 sacks class H and additives. Plugged down at 7:00 am on 11-9-83 and circulated 80 sacks. Tested casing at 600 psi for 30 min and OK. Logged and ran 7" casing set at 2962'. Cemented with 800 sacks class H and additives. Circulated 180 sacks cement and plugged down at 2:00 am on 11-13-83. Tested casing at 1400 psi for 30 min and OK. Rig released at 5:00 am on 11-13-83. Currently waiting on completion unit.
