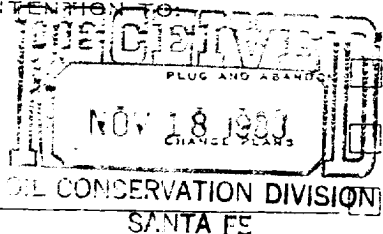

Circulated 283 sacks and plugged down at 11:30 am. on 10-29-83. Tested casing at 600 psi for 30 min and OK. Logged and ran 7" casing set at 2627'. Cemented with 750 sacks class H and additives. Circulated 193 sacks and plugged down at 12:15 pm on 11-2-83. Rig released at 2:45 pm on 11-2-83. Currently waiting on completion unit.
