On September 2, 1984 C02 in Action Rig #16 spudded a 12 1/4" hole at 9:30 pm. On September 4, 1984 ran 9 5/8" casing and set at 726 feet. Cemented with 390 sacks Class H cement with additives. Circulated 106 sacks cement to reserve pit. Plugged down at 1:04 pm on September 4, 1984. Wait on cement 12 hours. On September 8 ran 7" casing and set at 2571 feet. Cemented with 800 sacks Class H cement with additives and displaced 102 barrels 6% KCL. Maximum PSI to 800#. Circulated 240 sacks to reserve pit. Plugged down at 5:22 am on September 7, 1984. Nipped down the Blow Out Preventor and set slips and cut off casing. Rig released September 7, 1984 at 8:00 am.
