Shut-in for 2 hrs and flowed back to tank for 17.5 hrs. Tagged plug back T.D. at 2620'. Released packer and P.O.H. re-ran production equipment. Packer set at 2326' and seating nipple landed at 2318'. MISU 12-9-85 and flowed to tank 18 hrs. Turned thru separator for 45.5 hrs. Returned well to production. Operations completed 1-13-86.
