Moved in service unit 9-4-84. Ran 6 1/4" bit and drilled out to 2750'. Perforated intervals 2490 to 2512, 2516 to 2524, 2526 to 2578 with 2 SPF. Ran and set packer at 2356 ft. Rigged down and moved out service unit. Stimulated well with 9.5 tons CO2 with 4 Ball Sealers per BBL. Flw tested through a separator for 122 hours at an average rate of 1000 MCFD. Well shut in 9-15-84.
