MISU 12-10-85 and killed well with 30BW 2% KCL. Released packer and POH/tubing and packer. RITHa/packer and workstring. Set packer at 2312' and pressure tested 1500 psi. Frac stimulated with 210 BW 2% KCL, 54 tons CO₂, and 74,000# 8/16 sand. Shut-in for 2 hrs. Flowed back to tank 6 1/2 hrs. Tagged fill at 2798' and POH with workstring and packer. Re-ran production equipment. Tubing landed at 2473 and set packer at 2442'. MISU 12-16-85. Flowed to tank 18 hrs and thru separator 70.5 hrs. Operations completed 1-20-86. Returned well to production. PPWD: 1353 MCFD
