Flowed back to tank for 12 hrs. Tagged BSTD at 2740'. P.O.H. w/packer and workstring. Re-ran production packer and tubing. Tailpipe landed at 2407' and packer set at 2377'. MISU 12-9-85 and flowed to tank 18 hrs. Turned thru separator and flowed 13 hrs. Returned well to production. Operations completed 1-13-86.
