On August 21, 1984, C02 in Action (RIG 16) spudded a 12 1/4" hole at 3:30pm, drilled to 725 ft and set 9-5/8" casing, cemented with 390 sacks class H with additives and circulated 106 sacks to pit. Wait on Cement for 12 hours, tested casing to 1400 PSI and OK. On August 26 ran 7" casing and set at 2921. Cemented with 1050 sacks class H cement with additives and displaced 117 barrels KCL. Plugged down at 7:49 pm on August 26, 1984. Tested casing at 1700 PSI and circulated 155 sacks cement and nipped down blow out preventor. Rig released on August 26, 1984 at 10:30 pm.
