10-3-84. Circulated 56 sacks cement. Pressure test casing to 600 PSI and OK.
Wait on cement for 12 hours. On October 7, 1984 ran and set 7" casing @ 2845'. Cemented
with 600 sacks class H cement with additives. Plugged down at 7:15 PM 10-7-84. Circulated
66 sacks class H cement to reserve pit. Rig released at 10:00 PM on 10-7-84.
