Moved in service unit 12-1-84, perforated intervals 2495-2497 and 2503-2515 and 2519-2532 and 2535-2564 and 2572-2576 and 2580-2586 and 2588-2598 with 2 JSPF. Ran 3-1/2 tubing with 3-1/2 packer and set packer at 2363 ft. Tested packer with 1000 PSI and test ok. Ran swab unit with IFL 600 ft and recovered approximately 30 BLW. On 12-4-84 rigged up WEstern Company and pump 34 BBL liquid CO2 with 45 BBL liquid CO2 and 61.15 Gravity Frac balls per bbl. Rig down Western Company and flow to pit. Rig down and move out service-unit 12-4-84. Flow tested through a separator for 144 hours at an average rate of 55 MCFD.

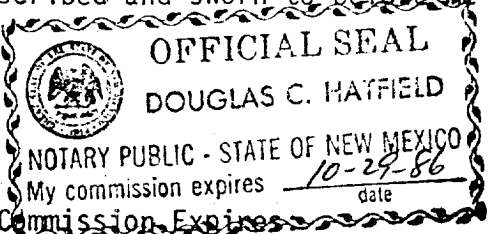
