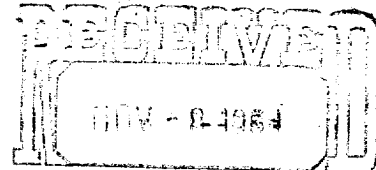

On 10-31-84 Aztec, Rig #56, spudded a 12 1/4" hole at 3:00pm and drilled to a total depth of 723 ft and set 9-5/8 casing. Cemented with 390 sacks Class H cement with additives. Plugged down at 5:45 on 11-1-84. Circulated 101 sacks cement to reserve pit. Wait on cement for 12 hours and tested casing to 600 PSI and ok. On 11-5-84 ran and set 7" casing at 2914 ft. Cemented with 875 sacks Class H cement with additives.

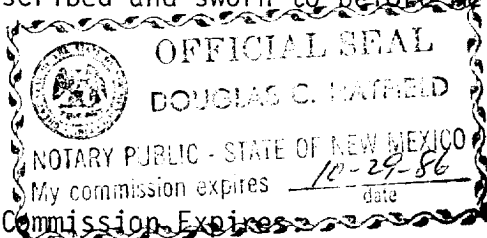
