On October 20, 1984 at 11:45 AM Aztec Rig #56 spudded a 12 1/4" hole. Drilled to a total depth of 722' and set 9 5/8" casing. Cemented with 390 sacks class H cement with additives. Plugged down at 2:30 AM on 10-21-84. Circulated 150 sacks to reserve pit. Wait on cement for 12 hours. Tested casing to 600 PSI and ok. On 10-26-84 ran and set 7" casing at 2813'. Cemented with 700 sacks class H cement with additives. Plugged down at 9:00 AM on 10-26-84. Circulated 280 sacks class H cement to reserve pit. Rig released 12:01 PM on 10-26-84.
