On September 18, 1984 Aztec Rig #56 spudded a 12 1/4" hole at 1:15 PM. Drilling to total of 762' and set 9 5/8" casing. Cemented with 390 sacks class H cement with additives. Circulated 75 sacks to reserve pit. Plugged down at 12:45 PM on 9-19-84. Wait on cement for 12 hours. On 9-22-84 ran and set 7" casing at 2658'. Cemented with 700 sacks class H cement with additives. Plugged down at 1:00 AM on 9-22-84. Circulated 271 sacks to reserve-pit. Rig released 4:00AM on 9-22-84.
