On 9-28-84 Aztec Rig 56 spudded a 12 1/2" hole drilling to a total depth of 725'. Ran and set 9-5/8" casing at 725 ft. Cemented with 390 sacks Class H cement with additives. Circulated 47 sacks to reserve pit. Plugged down at 7:00pm on 9-28-84. Tested casing to 600 PSI. Wait on Cement for 12 hours. On 10-2-84 ran and set 7" casing at 2791' ft. Cemented with 650 sacks Class H cement with additives. Plugged down at 9:01am on 10-2-84. Circulated 197 sacks cement to reserve pit. Rig released 12:00 noon on 10-2-84.
