MI and RUSU 5-21-87 and pull tubing and packer. Spot 86 gallons of sand. Run sinker bar on wireline and tag sand at 2516'. Run packer and tubing with packer set at 2167'. Frac with 142 bbls 40# HEC gelled with 2% KCl fw, 40,000# 8/16 sand and 45 tons CO₂. Average injection rate 35 BPM and maximum pressure 4210 psi. POH. Run packer and tubing with packer set at 2459'. RD and WOSU 5-28-87. Leave well in SI incomplete status.
