Move in service unit 1-20-85. Run in hole with tubing and packer. Tagged PBTD at 2587'. Pull up and set packer at 2457'. Pressure test casing to 1500 psi for 30 min. - OK. Perfed 2486-2504 and 2512-24 with 2 SPF. Set packer at 2458 and test packer. Acidized with 1000 gals 7½% HCL acid and 120 ball sealers. Flush with 23 bbls 2% kcl fresh water. Swabbed 47 blw and 5 BNW. Moved out service unit 1-24-85. No further report until additional work performed.
