On 9-18-85, Marfin Rig No. 22 spud the subject well with a 12 1/4" bit. Drilled to a total depth 714'. Ran 9 7/8", 32.3#, H-40 casing on 9-20-85 and set at 714'. Cemented with 425 SX class H cement. Circulated 30 BBLs cement to pit. WOC 18 hrs. Pressure tested casing 1200 psi for 30 mins. - ok. Reduced bit to 8 3/4" and resumed drilling. Reached TD by APD 9/25/85. Received verbal approval from Mr. Roy E. Johnson to Charles M. Herring to continue drilling at 2:50pm, 9-25-85. Drilled to a total depth of 3800'. On 9-27-85, ran 7", 20#, K-55 casing and set at 3800'. Cemented casing with 1425 SX of Class H cement. Circulated out 380 SX of cement. Rig released 4:00pm, 9-27-85. No further report until MICU.
