Propose to establish production in the Ellenburger Formation as follows:
MISU and RIH w/ workstring and bit. Drill out cement to 5400'. Spot 210 gals 15% HCl acid from 5400'-5360'. Perforate 5355'-80' with 4 JS PF. RIH w/ open hole packer and set at 5360'. Sank well to kick off flowing. Stimulate with 2500 gals 15% HCl acid. Flush with 60 BBLs fresh water. Sank and flow test well.
