Sitton Rig No. 1 spud the subject well 10-6-85 with a 12 1/4" bit. Drilled to a TD of 725'. On 10/7/85, ran 9 5/8" 36# K-55 casing and set at 725'. Cemented with 3905X Class H cement. Circulated 425X to pit. WOC. Pressure tested casing 1500 psi for 30 mins - ok. Reduced bit to 8 3/4" and resumed drilling. Drilled to a TD of 2586'. On 10/10/85, ran 7" 20# K-55 casing and set at 2586'. Cemented with 6505X Class H cement. Circulated 905X to pit. Rig released 3:00 am 10-11-85. no further report until MICU.
