Sitton Rig No.1 spud the subject well 10-20-85 with a 12 1/4" bit. Drilled to a total depth of 718'. On 10/21/85, ran 9 5/8" casing and set at 718'. Cemented with 3905X Class H with 2% CaCl₂. Circulated 30 BBls cement to pit. WOC. Pressure tested casing to 1200 psi for 30 mins - ok. Reduced bit to 8 3/4" and resumed drilling. Drilled to a TD of 2351'. On 10-24-85, ran 7" casing and set at 2351'. Cemented with 6505X Class H cement w/additives. Circulated 116 5X of cement to pit. Rig released 9:00 am, 10-24-85. No further report until MICH.
